# Business Litigation Firm Tackles Blockbuster Cases

The scene read like something you'd see in a movie. Thousands of innocent people, including vulnerable retirees, had been bilked out of an estimated \$200 million in a Ponzi scheme. The fraud had been committed by an array of unscrupulous corporations located throughout the United States and overseas. All hope seemed lost for over 140 investors when a large international law firm simply gave up on them and voluntarily dismissed their lawsuit. When they made that last call, they expected to hear the same thing they had heard from the other law firms: "Cases like this are just too complex and difficult to win. Sorry, we can't help you."

Enter the hero, stage left. One attorney, Tre Lovell, Esq., responded quite differently. He not only accepted the case, but expanded the scope of the previous litigation to include over 20 defendants in five countries and launched a \$100 million lawsuit. "This is what law is all about," he said.
